

Clinician Performance Information on Medicare Care Compare 2021 Doctors and Clinicians Public Reporting

Overview

The Centers for Medicare & Medicaid Services (CMS) is publicly reporting 2021 Quality Payment Program (QPP) clinician performance information on [Medicare Care Compare](#) and in the [Provider Data Catalog \(PDC\)](#). Per the Medicare Access and CHIP Reauthorization Act of 2015 (MACRA), eligible clinicians' final and performance category scores must be publicly reported. This document summarizes the 2021 QPP clinician performance information, plain language measure and activity titles¹, and utilization data that are publicly reported in 2023.

Performance information that meets statistical public reporting standards (valid, reliable, comparable, and meets the minimum reliability threshold) is reported in the PDC.^{2,3} A subset of this information is added to Care Compare profile pages. Any information publicly reported on profile pages must also resonate with patients and caregivers, as shown through user testing.

The 2021 QPP clinician performance information that is publicly reported on Care Compare and in the PDC includes Merit-based Incentive Payment System (MIPS) and Qualified Clinical Data Registry (QCDR) quality measures, MIPS Promoting Interoperability measures and attestations, MIPS improvement activities attestations, and final scores and performance category scores. The 2021 final scores and performance category scores (quality, Promoting Interoperability, improvement activities, and cost), as well as a subset of 2020 utilization data, are publicly reported in the PDC.
