SNF Provider Preview Reports - Now Available

Skilled Nursing Facility (SNF) Provider Preview Reports have been updated and are now available. The data contained within the Preview Reports is based on quality data submitted by SNFs between Q1 2019 and Q4 2019 (1/01/19 – 12/31/19) (for assessment-based measures) and Q4 2017 and Q3 2019 (10/01/17 – 9/30/19) (for claims-based measures). The data reflects what will be published on Nursing Home (NH) Compare during the October 2020 refresh of the website. Providers have until August 30, 2020 to review their performance data. Corrections to the underlying data will not be permitted during this time; however, providers can request CMS review of their data during the preview period if they believe the quality measure scores that are displayed within their Preview Reports are inaccurate.

Beginning with the October 2020 refresh, CMS will publicly display on the NH Compare website six new measures:

- Changes in Skin Integrity Post-Acute Care: Pressure Ulcer/Injury,
- Drug Regimen Review Conducted with Follow-Up for Identified Issues PAC SNF QRP,
- Application of IRF Functional Outcome Measure: Change in Self-Care (NQF #2633),
- Application of IRF Functional Outcome Measure: Change in Mobility (NQF #2634),
- Application of IRF Functional Outcome Measure: Discharge Self-Care Score (NQF #2635), and
- Application of IRF Functional Outcome Measure: Discharge Mobility Score (NQF #2636)

SNF performance data for these measures will be included for the first time on this preview report.

The following existing measures will continue to be reported as part of the October 2020 refresh:

- Application of Percent of Residents Experiencing One or More Falls with Major Injury (Long Stay)
- Application of Percent of Long-Term Care Hospital (LTCH) Patients With an Admission and Discharge Functional Assessment and a Care Plan That Addresses Function

NH Compare Quarterly Refresh with SNF QRP Data

The July 2020 Nursing Home (NH) Compare refresh, including quality measure results based on Skilled Nursing Facility (SNF) Quality Reporting Program (QRP) data submitted to the Centers for Medicare and Medicaid Services (CMS), is now available. For this refresh, SNF QRP assessment-based measures performance scores will be based upon data submitted to CMS between **Q4 2018 and Q3 2019 (10/01/18 – 09/30/19)**; claims-based measures performance scores will be based upon SNF Prospective Payment System (PPS) claims dated between **Q4 2016 and Q3 2018** (10/01/16 – 9/30/18).
