Reminder of Upcoming Data Submission Deadline

The submission deadline for the Skilled Nursing Facility (SNF) Quality Reporting Program (QRP) is approaching. Minimum Data Set (MDS) 3.0 assessment data for January 1 – March 31 (Quarter 1) of Calendar Year (CY) 2021 are due with this submission deadline.

All data must be submitted no later than 11:59 p.m. on August 16, 2021.

It is recommended that the applicable Centers for Medicare & Medicaid Services (CMS) Certification and Survey Provider Enhanced Reports (CASPER) are run prior to each quarterly reporting deadline to ensure that all required data were submitted. We encourage you to verify all facility information prior to submission, including CMS Certification Number (CCN) and facility name.
