What's Changed: We deleted HCPCS codes J7191 and J7199 and added J7177, J7178, and J7214 to the list of J codes on page 2.

- Adjustment of certain claims with the added codes

Background

Effective for discharges on or after October 1, 2022, CMS is adding these ICD-10-CM codes eligible for add-on payment for blood clotting factors you administer to hemophilia inpatients:

ICD-10-CM Code	Description
D68.00	Von Willebrand disease, unspecified
D68.01	Von Willebrand disease, type 1
D68.020	Von Willebrand disease, type 2A
D68.021	Von Willebrand disease, type 2B
D68.022	Von Willebrand disease, type 2M
D68.023	Von Willebrand disease, type 2N
D68.029	Von Willebrand disease, type 2, unspecified
D68.03	Von Willebrand disease, type 3
D68.04	Acquired von Willebrand disease
D68.09	Other von Willebrand disease

ICD-10-CM Code D68.0 is no longer eligible for add-on payment for blood clotting factors, effective for discharges as of October 1, 2022.

Your Medicare Administrative Contractor (MAC) will adjust any claims already processed for discharges as of October 1, 2022, and containing 1 of the above codes. They'll make these adjustments if the claim contained 1 of these HCPCS codes: J7170, J7175, **J7177, J7178**, J7179, J7180, J7181, J7182, J7183, J7185, J7186, J7187, J7188, J7189, J7190, J7192, J7193, J7194, J7195, J7198, J7200, J7201, J7202, J7203, J7204, J7205, J7207, J7208, J7209, J7210, J7211, J7212, J7213, **or J7214**.

Your MAC will complete these adjustments by June 1, 2024.
