The Common Working File (CWF), HETS' information source for Hospice information, experienced an issue between October 4-13, 2021. CWF performed maintenance that corrected the issue.

HETS was returning this information properly except for the cases where upstream systems have an invalid Patient Status Code of '00' on file for historical data. This issue was resolved.

The Common Working File (CWF), HETS' MSP information source, implemented system changes October 7, 2019. The CWF changes inadvertently resulted in sharing beneficiary MSP updates or new occurrences with HETS only when there are claims activity. The CWF MSP data was accurate, but HETS was not. If a beneficiary's MSP information changed after October 7, 2019, and there had been no CWF claims activity for that beneficiary, HETS MSP data was not current. While there was no impact to claims processing, if Providers submitted a claim to Medicare as primary payer based on HETS inaccurate MSP data and Medicare is not the primary payer, Medicare would deny the claim because Providers must bill the primary payer. However, that claim action would also update HETS MSP data to reflect another payer as primary. CMS corrected this issue November 18, 2019.</p>
<p>HETS was returning incorrect Hospice episode information or occurrence counts when the Medicare Beneficiary had a new Notice of Election (NOE) and had billed Hospice episodes four or more years ago.</p>	<p>1%</p>	<p>Prior to March 2019</p>	<p>November 4, 2019</p>	<p>HETS' data source for Hospice information is the Common Working File (CWF). CMS identified an issue where CWF was sending incorrect Hospice information to other systems (including HETS) when the Medicare Beneficiary had a new Notice of Election (NOE) and previously billed hospice periods. CWF updates the file and corrects the Hospice history once a Hospice claim is processed for the new billing period. CWF updated their database and processes to resolve these discrepancies and prevent future occurrences. The HETS 271 response was also modified to return all historic Hospice episodes instead of an occurrence count.</p>
